#### PAUL BARTHOLOMEW

Paul Bartholomew was present with his map of his property located at 54 Wallace Road (parcel ID #255.-4-8). He proposes to subdivide 16.53-acres from his 48.70-acre parcel. The current lot is owned by Mr. Bartholomew and his two sons. The proposed lot would be deeded to his son, Matthew so that he can build a home on the lot in the future. The proposed lot is divided by an existing road that connects to Jeffrey Hartley's property (recently purchased from John Robertson) who has a right-of-way. The Jackson Highway Superintendent has reviewed the driveway location. He signed the Highway Entrance Form giving approval and stated that the highway cut will need several loads of cleanfill at the entrance. The document is on file.
