RENEWABLE ENERGY LAW LANGUAGE

Chair Maxwell led a discussion on developing language for a Renewable Energy Law. The Town holds a public hearing for a six-month moratorium on renewable energy projects during the October 6 Town Meeting. The town board agreed to place a moratorium on renewable energy projects and stated it could be for six months, with the chance of four extensions of six months each, if needed. Chair Maxwell will give details to the town board on October 6 and report the cost of hiring Terresa Bakner from Whiteman Osterman & Hanna to help write the renewable energy law. Following the town board passing the moratorium, the planning board will begin drafting the renewable energy law.

The Planning Board discussed multiple reasons for hiring a consultant, including legal representation, liability, and increased efficiency.

In preparation for drafting the renewable energy language, the planning board members are reviewing several NYS Town's law language and identifying key concepts, exemptions and areas of concern.

Steve Chuhta indicated he would be attending and participating in an educational session on October 26 and Chairpoerson Maxwell will attend an open meeting on Solar on November 15. All Planning Board member were encouraged to attend training and keep the Board posted on attendance.
