TED DWYER

Ted Dwyer was in attendance with a sketch plan for a minor subdivion at 5 Kennedy Rd, Parcel: 231.-2-8.1. The Board approved the sketch plan and gave Mr. Dwyer approval to go to the next step of submitting an application.

ARTHUR MATATT

Arthur Matatt was in attendance with a sketch plan for a minor subdivion at 82 Plains Rd Parcel: 248.3-3-18. The Board approved the sketch plan and gave Mr. Matatt approval to go to the next step of submitting an application.

NOAH FALLON

Town Supervisor Jay Skellie was in attendance to discuss the possible need for a site plan review for Mr. Fallon on State Route 313, Parcel ID 241.-2-15.1. Mr. Fallon plans on building a personal storage shed on an existing cement pad. After discussion by the board it was decided that according to the town Site Plan Review Law section 302.12 the proposed project does require a site plan review as there is no primary building to make the storge shed considered to be exempt as an accessory building.

JACKSON SOLAR 1 LLC

The Planning board discussed the letter received from Borrego solar last month requesting a one year extension on the solar project at 2609 State Route 22. Chair Maxwell reached out to Teresa Bakner to ask her opinion. Steve Long from Borrego Solar was in attendance to answer any questions the board may have. A motion was made by Headwell and seconded by VandenBerg to approve the extension request from May 4, 2022 to May 4, 2023 with no possibility of any further extensions. Motion carried 5-0.

SOLAR LAW

Supervisor Skellie read and reviewed the planning boards Solar Law draft. Supervisor Skellie asked for the board to clarify a few points and recomneded a few wording changes. The board will fix the few changes needed to submit for the Town Boards review next month.
