LAKE LAUDERDALE CAMP INC.

Renee Carter was present on behalf of Lake Lauderdale Camp at 824 North Shore Way, tax map ID #232.17-1-37. Renee handed out copies of the sketch map. She explained there are issues with the lot as there is one cabin left near the water front that does not have its own tax lot and they are paying taxes on the entire 18.7-acre parcel that was once one big park. The Board discussed a possible two lot subdivision, but agreed it may be challenging to meet Town Subdivision Regulations with the potential obstacles the parcel presents. Board members agreed to look into the Subdivision Regulations further and reconvene on the issue in January.

COMPREHENSIVE PLAN COMMITTEE UPDATE

Committee member Erik Vandenberg has made edits to the draft Comprehensive Plan and will be making more based on recommendations made at the last Committee meeting. The next meeting will be pushed to the middle of January due to the holidays falling at the end of the month. He hopes to have an updated draft out by end of December.

COMMERCIAL BATTERY ENERGY STORAGE LAW UPDATE

Chair Donahue requested Board members forward all revisions to the draft law onto her or the Planning Board Clerk. She hopes to have a final draft prepared by January to then forward onto the Town Attorney.
