## **REPORTS**

Highway – There was no Highway Report for the month as Supt. Carney was absent from the meeting.

**Planning Board Report** – Planning Board Clerk Molly Dixson was present to report on Tuesday's meeting:

- There was a public hearing for a 1-lot minor subdivision off of Snuffy's Way with road access on State Route 22 that was subsequently approved.
- There was a discussion regarding a parcel on Lake Lauderdale that presented some challenges. The Planning Board will be looking into the possibility of doing a subdivision but will review the Subdivision Regulations this month and reconvene on the issue in January.

- The Comprehensive Plan has been drafted and is going through the final stages of editing. Erik VandenBerg plans on sending a copy of the draft out after Christmas.
- Chair Donahue has put together a draft Battery Energy Storage Law that has been sent out to Planning Board members for final comments. We hope to have a finalized draft for David to review in January.

#### **OLD BUSINESS**

**Update on Town Building Projects/ARPA Funds** – Supervisor Skellie advised that the Board needs to discuss ARPA funds and how we are using the remaining amount after the cost of the addition is taken out. With estimated figures, the Town has roughly \$40,000.00 left in grant money that will need to be allocated by the end of the year. Supervisor Skellie will get final numbers together to review at the Year-End meeting.

#### NEW BUSINESS

## **RESOLUTION #117**

A motion by Councilwoman Rich, seconded by Councilwoman VanDeWater; Resolution passed 5-0, to set the date for the Year-end Town Board meeting to Monday, December 30<sup>th</sup> at 1:00 pm.

#### **RESOLUTION #118-24**

A motion by Councilwoman Rich, seconded by Councilwoman VanDeWater; Resolution passed 4-1 with Councilman Rea voting against, **to hold the January, February and March Regular Town Board meetings at 1:00 pm.** 

**Planning Board Chair Resignation** – Amanda Weber has sent her resignation to the Town, effective January 1, 2025. Supervisor Skellie advised that the Town could draft a local law to go down to 1 appointed Assessor or find another person to appoint for the remainder of Amanda's term, which would have expired at the end of 2025. He will gather the Town's options and present them to Board members at the Year-end meeting.

**Content Farm Road Plowing Issue** – Chris Hunt of Content Farm Road spoke following a discussion he had earlier in the day with the Highway Dept. regarding snow stakes on the edge of his property being destroyed by the Town's plow after the most recent storm. He stated that the snow stakes were roughly 6 inches off of the side of the road. Supervisor Skellie and Councilman Rea both agreed that 6 inches is a little too close to the road and it can be challenging for the plow driver to avoid in heavy snow. Councilman Rea took Mr. Hunt's phone number to stay in touch going forward with this concern.
